- \$ 3,000 non-refundable retainer required for final reservation of services; balance due one week before the event.
- Mostly journalistic/candid photos *plus* formal portraits and group shots.
- Conceptual family shoot fee includes prep time, idea development, the shoot itself, and extensive Photoshop retouching. Client is responsible for fees related to props, locations, costumes, etc. Client will receive all images on CD, and prints of the final retouched image.
- Internet ordering / sharing allows you to share all or selected photos on password-protected website for guests to view and purchase prints. Offered assuming availability at time of event. Included in fee.
- Photographer reserves the right to make reprints/copies and use these for portfolio, promotional and editorial use.
- All photos/image rights remain property of Photographer until full payment of all fees and expenses.
- Prices are subject to change until both parties have signed this agreement.
- Sales Tax will be collected for photos delivered within the state of New York.
